GALS strongly believes in stakeholder engagement that allows for more collaboration with the community, builds trust and allows for more informed and better decision-making. Stakeholder feedback was solicited in the following ways:

- The ESSER III Expenditure plan was presented to the parents and guardians during a Coffee with the Principal meeting and School Site Council meeting. Parents and guardians were able to provide verbal or written feedback on the specific actions and expenditures proposed.
- The ESSER III Expenditure plan was reviewed and discussed during a board meeting that allowed for public to review and comment. The agenda for this meeting was posted 72 hours in advance of the meeting and included the location where the plan was available for public inspection
- The ESSER III Expenditure plan was reviewed and discussed with the GALS staff during a professional development meeting.

- The ESSER III Expenditure plan was reviewed and discussed with all members of the leadership team during several leadership team meetings.
- To the extent possible, the ESSER III Expenditure plan was discussed with civil rights organizations, advocates representing interests of children with disabilities, homeless students, foster youth and other underserved students versus separate meetings with the leadership team. GALS currently does not serve who are members of a tribe, migratory students or who are incarcerated.
- All information gathered through community engagement activities for both the LCAP and the ELO Grant Plan were taken into consideration when developing this plan.
- All meetings were promoted via newsletters that were translated in the stakeholder's primary language.
- GALS held a public hearing to gather input from the public at large. This meeting was held prior to the board approval of the plan. The input received during this public hearing was used to make adjustments to the final plan that was board approved.

- The input received via the meetings outlined above was used to make adjustments to the final ESSER III expenditure plan.
- The plan was influenced by the following feedback from stakeholders: The stakeholders were interested in the before school support and the addition of the paraprofessionals to the team. The stakeholders wanted continued support from the office staff in knowing what steps when a student or family member has COVID, where to get family members tested for COVID and to provide more information about the COVID vaccine and where to get it.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before September 30, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

 - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

- Providing mental health services and supports, including through the implementation of evidence-based full-service community schools;
- Planning and implementing activities related to summer learning and supplemental after school programs, including providing classroom instruction or online learning during the summer months and addressing the needs of underserved students;
- Addressing learning loss among students, including underserved students, by:
 - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
 - Implementing evidence-based activities to meet the comprehensive needs of students,
 - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
 - Tracking student attendance and improving student engagement in distance education;
