GALS engages its educational partners on the use of funds provided through the Budget Act of 2021 that were not included in the 2021-22 LCAP through a meeting with parents as part of the School Site Council Meeting. GALS consulted with teachers and the admin team at a professional development meeting. GALS consulted with the GALS Board of Directors at a public board meeting. GALS believes transparency is a key element to a successful relationships with educational partners.

GALS has added 6 paraprofessionals to the team this year to support teachers in the classroom to support learning intervention and acceleration. These paraprofessionals support the students through small group support, one on one support and through this support they give the credentialed teaching staff back time. This time allows our teachers to focus on creating more academically rigorous lessons and enhancing instructional practices.

GALS dialogs often with its educational partners. GALS held meeting with the parents, a separate meeting with the staff, and held a public board meeting to allow for any community members and the board to weigh on the use of funds.

The funding has greatly allowed us to support our students. Through the addition of 6 paraprofessional, before school tutoring program and through focusing specific credentialed teachers on social emotional supports for our students, we believe our students are making progress towards learning loss recovery. The challenge has been finding the time and resources to complete the additional compliance reporting that has been required while at the same time dealing with the Omnicron surge.

GALS has been using its fiscal resources to focus on decreasing learning loss and increasing academic rigor while providing strong social emotional supports to its students. Maintaining a safe facility that adheres to the best practices in COVID prevention has also been key to a successful year. This use of revenue is in alignment with our 2021-22 LCAP and Annual Update, the Safe Return to In-Person and Continuity of Services Plan and the ESSER III Expenditure Plan.
